

DigitalFlyer^(R) and the Community Business Token (CBT)

You can trade on DigitalFlyer^(R) using both FIAT (Government Currency) and Crypto

DigitalFlyer^(R) is bridging the gap between small to medium enterprises and the crypto world by introducing its own digital coin that can be used to do business using the CBT via the DigitalFlyer^(R) platform. Our CBT's Initial Coin Offering (ICO) is the start of a community-based crypto currency. CBT has been structured and designed to not only attach itself to any currency where business is conducted within the DigitalFlyer^(R) business platform, but it will also be tradable on the more popular crypto exchanges. CBT will be available as a tradeble coin for goods and services in the DigitalFlyer^(R) network.





The flexibility provided by CBT will allow customers and service providers to use their preferred payment method, whether it be normal electronic payment, cash or crypto currency. Crypto currencies are gaining international popularity and are increasingly accepted as a means of payment. It is widely discussed and rumoured that most financial institutions are adapting their service structures to accommodate the use of crypto currencies.

An added benefit provided by the CBT and DigitalFlyer^(R) business platform combination is that it allows you to complete online business transactions at a minimal fee by cutting out third party expenses and by charging no extra monthly subscription fees. You as the service or product provider are thus in full control of the funds being paid directly into your FIAT (banking currency) or crypto accounts. Burn and Allocation: At the close of the ICO, whether by time or "Sold-Out" all allocated CBTs will be transferred to the holder's preferred wallet, or remain within the DigitalFlyer wallet of choice. CBTs not allocated or sold during the ICO will be burned and only valid CBTs made available for market trading.


Registered CBT members will have their own secured Backoffice with a 2-way factor authenticator. From the Backoffice, registered members will:

Referral Structure

On top of the initial package and incentive bonuses, CBT members can also earn CBT's through the referral structure.

Our referral structure adopts a flat, one level method, and not a traditional multi-level marketing (MLM) structure. Each member is provided with a referral code who is then incentivised by a return received per referral. The value of the return is calculated based on the level at which the last ICO package was purchased.

The referral bonuses will be allocated as follows, during the 4 ICO stages:

The coins and cash allocation will only be granted once the referred purchase transaction is successful. The cash allocation can be used to purchase more packages or upgrade your current package status or be paid out in cash. Pay-outs will be done once a month, on all accounts holding a minimum of \$100 in cash bonuses





earned. Currently, cash pay-outs will only be possible to South African citizens holding a valid and legal South African bank account. We are busy investigating the most suitable solution for cash bonus pay-outs in the form of Bitcoin or Litecoin in the coming weeks for international members, meaning the cash bonus pay-outs might take some time before it can be paid out to international members.

An example of the referral incentive structure:

Let's say you have purchased a Bronze package and your referral purchases an Elite package using your referral link: Being at Bronze level, your bonus, during Stage 1, will be a 2%-coin bonus from \$1,000 PLUS a 5% cash back on \$1,000, meaning you will receive 6,666 bonus CBT's PLUS \$50 cash back bonus.

Using the same example above:

Should you have purchased an Elite package, and your referral also purchases an Elite package using your referral link: You will receive 50,000 bonus CBT's and \$200 cash back bonus!

The table below illustrates the bonus incentive matrix per stage and package, which shows that on an Elite package with 10 Elite Referrals, you will earn double your intial purchase PLUS another 500,000 CBT's.



User Interface and Communication

DigitalFlyer's business members will manage and administrate their tasks via a web interface available on all major web browsers. Basic tasks and communications will be done via the app interface.

Public user functionality will be available via the web and app interfaces. The app interface has been built on React Native for the fastest operation and phone OS integration. The app is available on iOS and Android stores.

All communication will take place digitally, utilising blog posts, via the member's back office which will keep business members and users updated on our latest news. Our own integrated chat module will provide a real time support platform where we can quickly respond to business member and user queries.
