
Migh-Throughput:

#### PROJECT ECONOMICS


#### **QUANTITY OF TOKENS:**

Total supply of PolluxCoin is limited to 5,00,00,000 POX which will be available in different phases. The Pollux coin will be released through Crypto Minting Units (CMU) in 35 phases. Initially CMU was purchased by paying in BTC, ETH, TRX. Pollux coin is already listed in various exchanges and will be listed in many more where it can be exchanged with crypto currencies like BTC, ETH, TRX etc.

Main issue with BTC and Ethereum is transaction speed and high transaction cost. In Bitcoin the rate of transaction per second is 3 BTC. Whereas in Ethereum rate of transaction per second is 25 ETH. Pollux coin (POX) has improved transaction speed having rate of transaction per second (TPS) 2000 POX.

Reserve fund for development team for future projects


#### **FUTURE PLANS**

DECENTRALISED CLOUD STORAGE PLATFORM


